# Detailed Guideline on Import License Allocation and Recommendation of Tariff Rate Quotas Under the Korea-U.S. FTA

#### 1. Basis

The Agro-fisheries TRQ Recommendation and Import Management Guideline Pursuant to the Free Trade Agreement Between the Republic of Korea and the United States of America (Ministry for Food, Agriculture, Forestry and Fisheries Public Notice No. 2012-32 ).

#### 2. Products and Quantity (Please refer to Annex 3)

- a. Fresh, curd grated or powdered, processed, and all other cheeses: 7,000 tons
- b. Food whey: 3,000 tons
- c. Prepared dry milk and other: 700 tons

#### 3. HSK Codes for Each Product Item (Please refer to Annex 4)

#### a. Fresh, curd grated or powdered, processed, and all other cheeses

## 4. Applicable Period: March 15, 2012 ~ December 31, 2012

#### 5. Applied Tariff Rate: 0%

# 6. Persons Eligible for Allocation and Recommendation: End-users such as historical and new importers, etc.

7. Application Period: March 15, 2012 ~ March 28, 2012 (2 weeks)

# 8. Agency for Allocation and Recommendation: Korea Dairy Industries Association

#### 9. Persons to Receive Allocation: Historical and new importers

- Shall be limited to importers who have received the Certificate of Livestock Product Import and Distribution Business prior to the date of the Public Announcement.

## 10. Allocation Criteria and Documents to be Submitted

a. Allocation Criteria

- Past two-year international import records will be given a weight of 95% and quantity requested for the quota year a weight of 5%.

- Notwithstanding, at most, the double amount of the quantity imported in previous year will be recognized as the quantity to be requested for the quota year.

b. Documents to be Submitted

- Historical importers: Past import records (documents certifying import records, etc.)

- New importers: New companies desiring to import

c. Upper Limit for Allocation: An upper limit per importer may be established at 20% or less of the total TRQ quantity, in order to allow for optimal allocations.

d. Minimum base quantity shall be 20 tons.

e. To allocate quantities to new importers that have received no allocation, 10% or less of the total TRQ quantity may be reserved for this purpose.

f. The reserved quantities and returned quantities that are remaining six months after the allocation shall be allocated to importers that need the additional allocations.

# 11. Country of Origin of Recommended Products: United States of America

# **12. Issuance of Recommendation**

- A Recommendation shall be issued for Korea-US FTA TRQ's if and when it is determined that the requirements in the *Agro-Fisheries Product Tariff Rate Quota Recommendation and Import Management Guideline Pursuant to the Free Trade Agreement Between the Republic of Korea and the United States of America* are met, in accordance with Ministry for Food, Agriculture, Forestry and Fisheries Public Notice (No. 2012-32).

# 13. Validity Period of a Recommendation

- The validity period for a Recommendation shall be ninety (90) days from the date of issuance. However, if the last day of the validity period is a national holiday, the Recommendation shall be deemed to expire on the first working day after such national holiday.

#### **15. Measures to Facilitate Fulfillment Rate**

- In order to facilitate full fulfillment of a TRQ (minimum fulfillment rate of 95%), the importer with the allocated quota must return the anticipated unused quantity at least six months prior to the pre-determined TRQ expiry date.

- In order to facilitate fulfillment, if the fulfillment rate of the allocated TRQ quantity is 95% or less with no quantity returned six months prior to the expiry date, the importer shall be excluded from the next round of allocation.

- As part of additional measures to facilitate fulfillment, the importer with the allocated import license may be requested to report on necessary matters such as fulfillment plan, etc.
