- Persons with a Trader Registration Number pursuant to Article 24 of the Foreign Trade Management Regulations (a person who has not been issued a Trader Registration Number shall have made an import agent service contract with one who has such Number)
- A. But participants shall be disqualified for 2013 allocations if a participant failed to import at the minimum of 95% of the allocated 2012 TRQ.
- B. In accordance with Article 15 of Public Notice No. 2012-302 (December 18, 2012) of the Ministry for Food, Agriculture, Forestry and Fisheries, any persons with restrictions to participate as bidders in import rights auctions or any persons listed as unfair trader in the Specified Information Processing System (G2B) that is specified and notified by the Minister of Strategy and Finance are not eligible to participate.

If the aggregate quantity requested exceeds the TRQ quantity available for allocation, then the Corporation will allocate the quantities among applicants on a *pro rata* basis, based on the amount requested.

8. Others

- Participants shall be disqualified for allocations the following year if a minimum of 95% of the allocated TRQ's are not imported by December 31, 2013 (based on date of processing of import notification as indicated on the Import Report Certificate) for each product item and company.
