The following table provides information on the fill rate of 19 products subject to Tariff Rate Quota (TRQ) under the KORUS FTA. The TRQ is allocated in 3 different manners: 1) First-come-first-serve basis, 2) TRQ auction and 3) TRQ allocation. The column headed "Status of TRQ auction / allocation" describes how much of the TRQ has been allocated or auctioned off to potential importers. This does not mean that the TRQ has actually been imported but only means that it has been allocated. The second column headed "Actual import status" describes the actual fill rate of TRQ and is based on actual entry of the products through Korean Customs. Once the fill rate goes over 100 percent, the imports will be subject to the basic duty rate. This information is supplied by the Korean Customs Service.
